- 8:45 am Depart by chartered motorcoach from Hudson Titus Plaza (525 Titus Avenue, Irondequoit, Section 11 in front of Wegmans).
- 9:00 Pick-up in Gates at the former Diplomat Banquet Center (1956 Lyell Ave, park in the rear of the back parking lot).
- 9:30 Pick-up at Saint Marianne Cope Parish/Guardian Angels Church (2061 E. Henrietta Road, please park near entrances).
- 10:30 Arrive at Ventosa Vineyards (3440 route 96A, Geneva), overlooking Seneca Lake, a "Taste of Tuscany in the Finger Lakes"! Enjoy an early lunch buffet featuring salads, pizzas, paninis and wraps. Wine tasting optional (own expense +\$18.00).
- 11:45 Depart from the winery and continue on to the Seneca Falls Train Depot (Academy Square on Park St. in Seneca Falls), where you will board the Finger Lakes Railway Train.
- 12:30pm Depart on a narrated scenic Fall Foliage train ride heading east over the tip of Cayuga Lake with views of the scenic Finger Lakes and the Montezuma Wildlife refuge.
- 2:00 Arrive back at the Seneca Falls Train Depot, reboard your motorcoach and continue on to Sauders Country Store (2146 River Road, Seneca Falls).
- 2:30 Enjoy browsing in family-owned Sauders Country Store, featuring Mennonite & Amish regional, homemade, specialty & natural flavors. 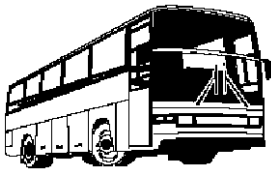

TERMS & CONDITIONS - DAY TOURS

Participant Agreement

By submitting a Registration Form and payment for any Bus America Day Tour, individuals agree to be bound by the terms and conditions of participation and cancellation as indicated below. Any individual tour may have additional terms and/or conditions that apply that and will be indicated on the specific tour flyer - travelers should review all tour documentation thoroughly prior to registering. Tours will be operated in accordance with all public health requirements and guidelines in place for the particular location/s at the time of the tour. Travelers will be required to cooperate with these requirements to participate, and failure to do so may result in a traveler being dismissed from a tour without refund.

Price/Group Size: Tour prices are based on a minimum group size. If tour enrollments do not reach the required minimum group size, Bus America will offer the travelers the option to transfer their registration to another tour or receive a refund. Operational decisions will be made no later than 2 weeks prior to a scheduled tour.

Reservation and Payment Schedule: Reservations will be confirmed when a completed Registration Form is submitted with the tour deposit or full payment as indicated on the tour flyer. Registrations are accepted by mail, by phone, or online – see Registration Form for instructions and details. Generally, full payment for Day Tours are due 30-45 days prior to departure, however, each tour flyer will indicate the due dates for deposits and balances, and/or full payment.

Tour Schedule: Prior to departure, Bus America will notify travelers if any changes are necessary to the pick-up, return, or activity time schedule that is indicated on the initial flyer. Pick up locations are subject to change as approximately 8 travelers are needed at each pick up location. Your tour manager will always do their best to adhere to the original time schedule as planned, however, cannot be held responsible for deviations or tardiness caused by unforeseen factors such as weather, traffic, etc. Please arrive 10 minutes prior to the scheduled departure time, tours cannot wait for late travelers.

Tipping / Gratuities: Gratuities for tour managers and motorcoach drivers are included in all Bus America prices. However, travelers should feel free to express their gratitude for exceptional service through additional gratuities on the day of services at their own discretion.

Traveler Documentation: Participants must comply with identification or documentation requirements as indicated on the tour flyer, such as a photo I.D., and/or (for Canada) a Passport, Passport Card, or Enhanced Drivers' License.

Cancellation Policy: Day tour cancellations are accepted by phone, mail, or email to info@grouptoursinc.com. Refunds will be provided within 15-30 days from the date of cancellation. The following cancellation penalties apply:

29 to 14 days before departure
13 to 1 day before departure or "no shows"

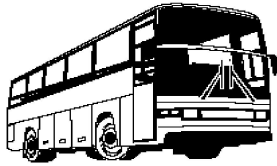
